Residing and acting wherever there is an interface between the body and the outside environment, antibodies of this class play a decisive role with regard to preventing many common infections.

9. The Identification and Significance of Gamma E 84

Although it has long been believed that a special class of antibodies is involved in many common allergies, the precise nature of these immunoglobulins was first shown by the work described here.

At least nine different components are involved in the complement system, which is responsible for much of the tissue injury that may follow in the wake of antigen-antibody interactions.

The ability to effect cell-free transfer of delayed hypersensitivity opens up the possibility of treating derangements of cellular immunity without hindrance by host defense mechanisms.

12. Chemical Mediators of Immediate Hypersensitivity 115

Two chemical substances, histamine and srs-A, mediate the interactions that may eventuate in immediate hypersensitivity and anaphylaxis. The value of blocking agents is discussed.

13. Immunologic Unresponsiveness 123

Just as immunologic reactions are specific, so are the reactions that lead to tolerance. How is a tolerogen defined and how can our present knowledge of tolerance be exploited clinically?

14. The Interrelationship of Clotting and Immunologic Mechanisms 135

The same enzymes acting upon different substrates can induce clot formation, clot dissolution, and such immunologic events as complement activation. The role of Hageman factor is critical.

15. Lymphocytic Factors in Cellular Hypersensitivity 146

Chemicals produced by lymphocytes mobilize macrophages to participate in cellular hypersensitivity reactions. The nature and function of these mediators are described in detail.

Immunologic injuries are initiated by antibodies that may either be specifically directed against antigens in target tissues or be components of circulating immune complexes.
